**3. "About Planning" Presentation**

Jean Lecuyer gave a presentation about planning. The presentation discussed the four pillars to a good plan, which are the mission statement, the set of values, the external scan, and the internal assessment. The components of a good plan are a vision statement, goals, strategies, performance indicators, and objectives. The plan is implemented through implementation plans. Two major committees are responsible for planning, the decision makers (Team A, aka the Master Planning Committee) and the planners (Team B, aka the Planning Resource Committee).

#### **4. Review of College Mission Statement**

Team A reviewed the college mission statement, following the annual procedure outlined in the Planning Handbook. The committee discussed the possible addition of an explicit statement about distance education in the mission statement, but decided not to recommend any changes.

#### **5. Presentations to Inform Master Planning**

Two presentations were given to help inform the master planning process. Ed Karpp gave a presentation on trends in demographics, student satisfaction, faculty/staff satisfaction, and institutional effectiveness indicators. Jill Lewis gave a presentation highlighting examples of SLO and PLO assessments leading to improvements in different divisions.

#### **6. Revisions to the EMP**

Isabelle Saber referred to the fact that the college is scheduled to revise the Educational Master Plan (EMP), starting this year. She plans to make two broad changes to the EMP. One change is aligning the major goals of the EMP with the accreditation standards. The other change is to tie EMP goals more strongly to the budget process. Team B will work on these revisions during the Fall semester and recommend the changes to Team A in Spring/Fall 2014. Participants were invited to contact Isabelle with their input.
