Call to Order: The meeting was called to order by Ed Karpp at approximately 1:00 p.m.

- I. Steve Marsden Report
 - a. The report that was created by Steve Marsden in 2012 was reviewed.
 - b. Comparisons from our budget were made with the 13 colleges we associate with.
 - c. The goal of the report was not to come up with definitive answers but to come up with questions we needed to look at.
 - d. We spend approximately 90% of our money on salaries which is high.
 - e. Our budget is hard to analyze in comparison to others because we self-insure.
 - f. Steve Marsden stated that there is a lot of garbage in the report but he included everything so as not to be biased.
 - g. Key issues in the report included:
 - i. 2008-2011: 6,000 GTE students were educated for no revenue. Other colleges did the same but they built up their reserves.
 - ii. We lost a lot of non-resident students at that time.
 - h. The data in this report is over four years now and therefore no longer pertinent.
 - i. Ron Nakasone addressed the report.
 - i. When the report came up at the last Team A meeting the biggest concern was why are we looking at a report that is four years old?
 1. Looking at the report will help identify if we have the same concerns.
 - ii. Ron presented a handout with observations from the summary of the Steve Marsden report.

- II. Growth
 - a. The topic of growth was brought up.
 - b. The college should be spending more time and money in marketing to make the institution more successful so we can establish a pattern of growth rather than just squirreling money away.
 - c. We need to identify what we have that other colleges do not. What makes GCC unique?
 - d. We need to look at unique programs again that will generate a different population.
 - e. A question arose as to what the best avenue would be to make a recommendation to the Board?
 - i. Both Team A and Budget could make a recommendation.
 - ii. Student Affairs meets Wednesday. Somebody could make a recommendation that growth be addressed.
 - f. Advertising needs to be a priority now. Marketing needs to move forward in order to increase growth.
 - g. It was requested that a task force be created to look into potential ideas for growth.
 - i. The Enrollment Task Force Committee will reconvene and look at this.
