- 1. Board members primary attention is on policies to assure the academic quality, integrity and effectiveness of the student learning programs and services and the financial stability of the college and to issues related to the four Strategic Goals in the GCCD Educational Master Plan: 1) students awareness, access, persistence and success, 2) economic and workforce development, 3) instructional programs and student services, and 4) fiscal stability, diversification, and enrollment management; and to facilities and institutional operations.**
 - Provide oversight and support to increase enrollment so as to serve the education and job training needs of the community and assure the fiscal stability of the college
 - ✓ Monthly information reports provided to the Board on enrollment
 - Maintain oversight of the college budget including an expectation of timely informative meetings, the setting of budget benchmarks, and five-year budget projections
 - ✓ Board discussion and public hearing on 2017-18 budget with five year projections (August 14, 2017)
 - ✓ Discussion and adoption of 2017-18 budget (Sep 12, 2017)
 - ✓ Review of financial data comparisons and five year expenditure and revenue trends (January 20, 2018)
 - ✓ Receipt and review of annual fiscal audit which included no negative findings (January 16, 2018)
 - ✓ Review and discussion of tentative 2018-19 budget (June 19, 2018)
 - ✓ Paid off \$2.3 million of certificates of participation with Measure GC funds saving \$285,000 annually from general expenditures
 - ✓ Facilities Master Plan updated (September 12, 2017)
 - ✓ Board review and action on Garfield Campus property acquisition for surface parking, College Police facility renovation, purchase of Citibank Building in Montrose to expand credit and noncredit offerings in northern Glendale, new Athletics Facility, renovations and improvements for Library and Sierra Nevada, completion of Sierra Vista, and MOU with City for joint-use fire training facility
 - ✓ Six new members appointed and four reappointed to Facilities Bond Oversight Committee which held four meetings
 - Review the GCC vision for online education and consider what appropriate policies and support are necessary to assure its effective use in fulfilling the college mission
 - ✓ A new DE Coordinator was appointed this year and she has reviewed, updated, and clarified the qualifications for teaching an online course. These have been approved through governance and the Academic Senate.
 - ✓ A reliable and accurate list of approved instructors in DE has been created and provided to Division Chairs.

- ✓ The college adopted the @one training for DE instructors and invested in offering its own course with a GCC instructor to provide training free of charge to any faculty member interested. Faculty will also receive salary unit credit for completing the course.
 - ✓ The college has been accepted to participate in the statewide OEI (Online Education Initiative) and is currently preparing for this new endeavor.
 - ✓ The college has adopted a portion of the OEI Course rubric to ensure that its online courses are rigorous and accessible.
 - ✓ The college is exploring the use of Ally by Blackboard, for use in Canvas to greatly increase the accessibility of materials in online courses.
 - ✓ The number of faculty qualified to teach online has greatly increased and we have seen strong interest and growth in students taking online courses, particularly in English and Speech.
 - ✓ The Committee on Distance Education has reworked and updated the Mission Statement and Vision for Distance Education and is currently completing the DE Component Plan for the 2018-2025 Institutional Master Plan
- Receive status reports and provide leadership support on GCC efforts to implement the Guided Pathways model
 - ✓ Monthly reports on the status of implementation received starting in September 2017
 - Support GCC efforts to expand the use of open education resources (OER) and to explore establishment of zero-textbook-cost degree programs, and other approaches to the reduction of textbook costs for students
 - ✓ The college received a grant to complete a ZTC Degree (Zero Textbook Cost) in Childhood Development.
 - ✓ The bookstore manager is working with the Library and publishers to offer more OER materials on campus.
 - ✓ Workshops have been provided to faculty on the use of OER, informing them what they are and how they can be used.
 - ✓ The Library has acquired a collection of the OpenStax, OER textbooks for faculty to examine when considering their use.
 - ✓ The Faculty Innovation Center has an OER workroom with scanner and computer for faculty use.
